Overview, Target Audience and Learner Outcome

This virtual conference combines clinical presentations, as well as reviews of available evidence for current practice strategies related to the anticipation, recognition, assessment, stabilization, and acute and long-term care of the neonate. This conference will of interest to NNPs, NICU nurses, neonatal providers and other staff involved in the care of NICU patients. At the conclusion of this event, the participant will report increased knowledge and intent to change practice related to best-practice and innovative solutions for patient care in the NICU.
