# **Course Description**

Research examining feeding and eating disorders highlight the necessity for comprehensive and evidence-based cognitive and behavioral interventions. This course will offer opportunities to increase competence, understanding, and skills in feeding and eating disorders. Specifically, the course will provide an overview of what is known about a newly recognized diagnosis — avoidant/restrictive food intake disorder (ARFID) — which is defined by an inability to meet nutritional needs due to sensory sensitivity, fear of aversive consequences, and/or lack of interest in eating or food. This session provides an overview of what is known about ARFID followed by specific instruction in the application of a novel cognitive behavioral therapy approach for children, adolescents, and young adults with ARFID. Novel treatment approaches for common feeding and eating disorders in childhood will be a focus during breakout sessions.

#### **Objectives**

Upon completion of this conference, participants should be able to:

- Describe diagnostic categories and differential diagnostic categories for children with eating and feeding disorders.
- Recognize how to assess and diagnose DSM-5 avoidant/ restrictive food intake disorder.
- Identify evidence-based treatment approaches for pediatric patients with eating and feeding disorders.
- Describe the basic structure and principles of cognitivebehavioral therapy for avoidant/restrictive food intake disorder (CBT-AR).
- Describe for whom CBT-AR is appropriate and how to tailor treatment based on the ARFID presentation.
- Outline strategies to support recovery from eating and feeding disorders in pediatric patient populations at home, at school, and via psychotherapy.
- Discuss potential changes to organizational practice guidelines to screen and treat children with feeding and eating disorders.

Kamryn T. Eddy, PhD

 $Associate\ Professor, Department\ of\ Psychiatry, Harvard\ Medical\ School$ 

Co-Director, Eating Disorders Clinical and Research Program, Massachusetts General Hospital

Dr. Kamryn Eddy is an Associate Professor of psychology at Harvard Medical School and the co-director of the Massachusetts General Hospital Eating Disorders Clinical and Research Program. She is a clinical psychologist with expertise in the assessment and treatment of eating disorders. She is a Fellow of the Academy for Eating Disorders and President of the Eating Disorders Research Society and her research is supported through the National Institutes of Health and private foundations. Her program of research focuses on diagnosis, treatment, and neurobiological bases of eating disorders, and longitudinal outcomes. She is the principal investigator of several studies, including two NIMH-funded studies of the neurobiology of low weight eating disorders, and a novel hormonal treatment study of anorexia nervosa and the female athlete triad. The overarching objective of her work is to carefully describe the clinical presentations of individuals with eating disorders in order to address questions about why, and in whom these illnesses are most likely to develop, and to inform the development of novel treatments for these serious conditions. Along with her colleague, Dr. Jennifer Thomas, Dr. Eddy developed a novel cognitive-behavioral therapy for avoidant/restrictive eating disorder (CBT-AR), which was published by Cambridge University Press. She has mentored numerous postdoctoral fellows, medical residents, and psychology graduate students.

Jenna Glover, Ph.D. is a Licensed Psychologist and an Assistant Professor in the Departments of Psychiatry and Pediatrics at the University of Colorado School of Medicine. Dr. Glover serves as Director of Psychology Training at Children's Hospital Colorado. She has previously worked as an Assistant professor at Washburn University and Utah State University as well as serving as the lead psychologist at Avalon Hills a residential eating disorders program. Dr. Glover's research interests include improving patient experiences of psychological evaluation through therapeutic assessment and identity and relationship development in LGBTQ youth. Dr. Glover's clinical work focuses on utilizing motivational interviewing and acceptance based therapies with adolescents across a range of disorders. Dr. Schiel is an attending psychiatrist for the Eating Disorder Program at Children's Hospital Colorado. She works with a multi-disciplinary treatment team to provide family-based care for youth with a variety of eating disorders and often co-occurring conditions. Lauren Shomaker is a child clinical psychologist who specializes in adolescent depression, eating behavior, and obesity. Dr. Shomaker conducts research on evidence-based interventions for adolescents with depression and obesity, with a particular focus on youth with, and at highrisk for, prediabetes and type 2 diabetes. Dr. Shomaker studies interpersonal psychotherapy, mindfulness-based interventions, and cognitive-behavioral therapy. She also provides health and behavior assessments and brief psychotherapy to youth and families in Children's Hospital Colorado's Lifestyle Medicine weight management program.
