Overview, Target Audience and Learner Outcome

Each Collaborative Case Review will describe a case associated with a possible adverse event and explore the <u>system and</u> <u>clinical reasoning factors</u> that may have contributed to this or similar cases for CHCO team members, faculty, fellows, and residents. After participating in this education, participants will report increased knowledge of their contribution to system improvement and their role as members of the diagnostic team. Learners will report at least one practice change they intend to make are a result of this education.

Objectives

- Examine how system factors and cognitive factors contribute to preventable harm.
- Discuss insights on possible solutions to address these factors.
