OVERVIEW AND TARGET AUDIENCE

This activity is for interdisciplinary healthcare team members caring for pediatric patients in an emergency and prehospital setting. We will provide clinical updates and address current topics relevant to the care for sick and injured pediatric patients.

LEARNER OUTCOME
