Virtual Education Series: Moving Towards Equitable Perinatal Toxicology Screening and Testing

Overview, Target Audience and Learner Outcome

This activity for the interdisciplinary healthcare team will include a review of current literature and clinical pathways followed by Children's Hospital Colorado for perinatal toxicology screening and testing. In addition to a presentation from content experts, attendees will participate in case study review and discussion to provide direction on clinical practice. As a result of this activity, learners will be able to report new knowledge related to equitable perinatal toxicology screening in order to provide current, evidence-based care.

Objectives

- Describe how toxicology screening and testing is commonly conducted in the perinatal period and risks of bias in this process.
- Identify strategies to shift clinical practice and organizational policy to ensure equity in toxicology screening and testing during the perinatal period.
- Discuss successes and challenges of implementing new state guidelines within a hospital system.
