Overview, Target Audience and Learner Outcome

This activity for the interdisciplinary healthcare team will include a review of current literature for the evaluation, treatment and management of pediatric patients encountered in the prehospital or emergency setting. Objectives

3. Review pre-hospital wound care of pediatric burns.
